

RESOLUTION NO. 2007-10

STATE OF TEXAS § **A RESOLUTION STATING THE INTENTION OF THE CITY OF WESLACO TO ANNEX INTO ITS CORPORATE LIMITS, ON OR BEFORE MAY 2010 THE AREA**

COUNTY OF HIDALGO § **COMMONLY KNOWN AS TESORO ESTATES SUBDIVISION, PHASES I, II AND III, SAID ANNEXATION TO BE ACCOMPLISHED PURSUANT TO TEXAS LOCAL GOVERNMENT CODE CHAPTER**

CITY OF WESLACO § **42, SUBCHAPTER C.**

WHEREAS, on this same date, May 1, 2007, the City Commission of the City of Weslaco, adopted on first reading a General Annexation Element and Plan; and

WHEREAS, Weslaco's Annexation Element and Plan sets forth the policies, procedures and priorities that the City Commission of the City of Weslaco will consider when it extends its municipal services, regulations, voting privileges and taxing authority to new land in its extraterritorial jurisdiction; and

WHEREAS, Weslaco's Annexation Plan identifies 58 tracts of land to be considered for annexation; and

WHEREAS, Weslaco's Annexation Plan includes among the policies to guide annexations by the City of Weslaco that the City will annex tracts that are contiguous to Weslaco's city limits, that have public water and wastewater treatment services; and

WHEREAS, Tracts B, as identified and described in Weslaco Annexation Plan, also known as Tesoro Estates Subdivision, Phase I, II and III, is contiguous to the City of Weslaco's city limits and has public water and wastewater treatment services and is therefore identified for potential annexation; and .

WHEREAS, Texas Local Government Code (LGC) §43.052(b) requires that annexation of certain areas be accomplished pursuant to a municipal annexation plan, commonly referred to as a Three-Year Annexation Plan; and in compliance with the processes and procedures governing said Three-Year Annexation Plan; and


WHEREAS, Texas LGC §43.052(c) provides that said annexation plan shall specifically identify annexations that may occur beginning on the third anniversary of the date the plan is adopted.

NOW, THEREFORE, BE IT RESOLVED that the City Commission of the City of Weslaco by adopting this resolution hereby adopts a Three-Year Annexation Plan and said Three-Year Annexation Plan establishes that it is the intention of the City of Weslaco to annex into its corporate boundaries on or before May of 2010, the land also


known as Tesoro Estates Subdivision, Phases I, II and III (the metes and bounds descriptions of this subdivision are available on the recorded plats.)


