




A Special Meeting of the Weslaco City Commission

Discussion and consideration to approve the interlocal agreement with Hidalgo County Precinct 1 and Texas Department of Transportation (TxDOT) to fully fund engineering, environmental, survey, the acquisition of right-of-way, adjustment of utilities and construction of Mile 6 West (Westgate Drive) to widen and re-construct from Mile 9 North to Mile 11 North for an amount not to exceed 20% of the total project cost, authorize a budget amendment as appropriate, and authorize the Mayor to execute any related documents. As the Mayor calls upon those who submitted a registration form with the City Secretary, please step to the podium and state your name and address before beginning your presentation.
